1. BASIC RIGHTS

Proceedings against move to Family Location

In principle, families who have exhausted their appeals are to leave the reception centre after 28 days. Since turning them out into the streets is not allowed, these families are moved to a Family Location. This option also applies to families who may remain in the Netherlands pending the outcome of other (regular) proceedings. As a result of criticisms levelled at these moves, the minister has declared that medical care and schooling must continue to be guaranteed in the Family Location. If these facilities have not been properly taken care of, proceedings may be instituted against the move.

2. ADMISSION POLICY

Permits revoked faster in case of criminal record

Minister Leers proposes to revoke a residence permit faster if the alien is convicted for a criminal offence. During the first three years, a residence permit may be revoked after any criminal conviction to an offence on which two years' imprisonment is threatened. After three years, the permit can only be revoked after an offence on which longer prison sentences are threatened. After three criminal offences, the alien is seen as a persistent offender, to whom a stronger sliding scale applies. However, the minister will always keep the individual circumstances into account (parliamentary paper 19637 no 1494, 6.2.12)

Minister intends to make family reunification harder

Minister Leers intends to make stricter demands on family reunification. The following measures apply:

- Admission for the spouse and minor children only. For partners who cannot marry in the country of origin (homosexuals for instance) a marriage visa is made possible. In that case, the partners are to get married in the Netherlands within six months in order to apply for the residence permit.
 - The partner in the Netherlands must have lived here at least one year before the family reunification can take place.
 - An independent residence permit is only issued after five years instead of after three years.

So far, 25 municipalities in favour of children's pardon

More and more municipalities sign the petition for a children's pardon. The political party GreenLeft has joined forces with the Dutch Labour Party and the Christian Union and supports the legislative proposal to give children a residence permits after an eight-years' stay in the Netherlands. As many as 124,000 people have already signed the petition on www.kinderpardon.nu.

3. CHECK AND DEPORTATION

Minister: building 4 of Zeist Detention Centre will be improved

As a result of proceedings by the Dutch Association of Asylum Lawyers, the minister has promised that the air quality in building 4 of Zeist Detention Centre is to be improved. The Implementation of Sanctions Inspectorate has criticized the air quality in building 4 since 2010.

Minister: seven people left after unlawful checks on domestic workers in Kennemerland

In response to parliamentary questions, the minister stated that the aliens police was not allowed to check the residence permits of African charwomen in Kennemerland, since there was no probable cause to suspect illegal stay. However, as a result of the checks, seven people departed from the Netherlands, some of them voluntarily, others under duress. The employers have not been fined.

The vast majority of asylum applications are rejected, forcing people to return to extreme dangers. In order to survive, many choose to live hidden without any legal rights.
