## DUTCH DOCTORS OF THE WORLD: CALLS FOR EMERGENCY SHELTER IN THE WINTER MONTHS

The Dutch section of Doctors of the World (Dokters van de Wereld) sent an appeal to the Dutch Cabinet to continue emergency refuge facilities:

*'We call on the government to transform the temporary homelessness policy into a sustainable 24-hour shelter with counselling. The current situation of emergency shelters needing to close and open again due to the alternating implementation and cessation of entire or partial lockdowns and other corona-related measures is rather confusing, labour intensive and expensive.*

*Ensure that shelter is available to all, at least up to 1 April 2021. All people in the Netherlands need to stay as healthy as possible, in the coming months. This also applies to the homeless, irrespective of their status.'*

## ADMISSION POLICY

### European Court of Human Rights (ECtHR): interest of the child outweighs criminal record of the father

This case was in Great Britain. The Nigerian parents of three young children were convicted of having forged residence permit applications. The father lost his residence permit due to his criminal record. The lawyer filed a complaint about this to the European Court of Human Rights (ECHR). His main argument concerned the interest of the children — particularly the youngest child, who has a heart condition and is in need of surgery. Therefore, this child requires a large amount of care.

The ECHR ruled that the residence permit of the father should not have been revoked. See [here](#).

### District Court: partner has no interest in the ruling on the temporary entry permit (mvv) because he is already staying in the Netherlands

This Nigerian man applied for an mvv (temporary entry permit) so that he could join his marital partner. His application was rejected. Meanwhile, he travelled on a visa to the Netherlands where he applied for asylum. He wanted his mvv application to be reconsidered. The IND was of the opinion that this was unnecessary, as he was already in the Netherlands. The judge agreed with this opinion. See [here](#).

### District Court: letters by doctors and police reports are insufficient evidence of domestic violence

When a relationship with a foreign partner ends due to domestic violence, the IND can issue a residence permit on 'non-temporary humanitarian grounds'. Domestic violence needs to be proven by letters from the police and assistance providers.

In this case, there were letters by a psychologist and a general practitioner, as well as a police report. However, the IND was of the opinion that these letters were drafted too late; the woman should have already talked to her doctor about the domestic violence before she broke off the relationship. The police report was also deemed not objective, because it was based on her own statement. The judges agreed with this opinion. See [here](#).

### District Court on a pardon for children: opportunities for children borne after completion of their parents' asylum procedure or criminal record

In two rulings, judges ruled on applications by children for the 'Afsluitingsregeling Kinderpardon' (i.e. completion regulation on a pardon for children). One case concerned children born after their parents completed the asylum procedure; the other case was about a child with a father who had been convicted of a crime (in 2005, before the child had been born). In both cases, the judge ruled that the children were eligible for the completion regulation (i.e. the 'Afsluitingsregeling'). See [here](#) and District Court of Middelburg, 20/761, 5.11.20.
